






CLUB SPONSOR

Similarly to other Association Special Interest Groups, annual Club Member volunteer efforts at the Schutzenfest had been rewarded with significant donations until 2015.



2018 A YEAR OF CHANGE

2018 has been one of the most significant since formation of the German Table Tennis Club as a Group of the SA German Association in 1958.

Due to the sale of the Association building at 223 Flinders Street Adelaide and the lack of any future plan for the SA German Association, the Table Tennis Club members unanimously voted to become an incorporated association. This structural change occurred on 28 September 2018.

At the end of the year, the Table Tennis Club was investigating future venues to ensure maintenance of the Club and potential for it to grow.

LUB HISTOR

The table tennis group has been part of the South Australian German Association (SAADV) since 1958. Its loyal members have varied annually from a previously capped number of 20 to this year's record number of 36. The increase was possible by adding the additional Thursday night training period to the long existing traditional Monday nights. They range from teenagers through to veterans and from beginners through to members with some past players ranked in Australia's top 100.

Club practise is still in the Friedrich Jahn Gymnasium on four tables, generally followed by a few drinks in the bar down stairs. Our Club is associated with Table Tennis SA and a number of our members compete in their winter pennant competitions, both for our club and other table tennis clubs. Our club organises quite a few social activities with our annual BBQ, exchanges with other clubs and our Christmas dinners being the highlights of the year. All table tennis enthusiasts, whether beginner or advanced are invited to come and see us for a trial.

Jenny was the Female Club Champion every year from 1979 to 1999 except in 1980. An amazing record. She was a State representative player and an outstanding player throughout her successful table tennis career.

Her last involvement with the Club prior to her death was at the 2001 AGM.

PRESIDENT'S REPORT

This report is from August to December 2018, following on from our AGM and subsequent incorporation as the German Table Tennis Club Inc.

Our club continues to grow with many members actively involved in state, interstate and national competitions.

Our Division 2 team made the grand final in Table Tennis SA's winter pennant competition and many of our members competed in various other teams across the competition.

This year our club continues to grow reaching record numbers and this showed with record entries in our club championships held in early November.

On the social side our Christmas dinner was again well attended, members also held a pinball competition and continued to enjoy social activities around our table tennis.



This report only covers the period from 1 July to 31 December 2018 due to the new constitution changing the financial year to a calendar year. This is now in line with Table Tennis SA reporting.

The major activity has been the writing and processing of the new constitution.

New Club shirts have been ordered and received for new members joining since July 2018.

The Club finances are a healthy \$4,394 cash in the bank as at 31 December 2018. Due to the record number of members (36), membership fee income was highest on record at \$1,750. Use of this money has been conservative as the Club explores new premises. The new accommodation cost is still unknown, hence minimising Club expenditure during the year.

Club fees have been maintained at \$50 per member plus SA German Association membership since 2015. This rate will be reviewed in line with future accommodation. A special members meeting will be arranged when we have a proposal for relocation.

The Club has continued to maintain a friendly atmosphere with all members contributing in their own way to support ongoing Club operations.
